Frustrating wait to serve the govt

Pharmacy graduates have been waiting a long time for offer letters and job placements for compulsory government service.

We attended our interviews in September at the Public Service Commission's office in Putrajaya and were told we would receive our offer letters within a week.

We did not know it was going to be such a long wait. When I enquired, the PSC and Health Ministry said the delay was because of a lack of placements for pharmacy graduates.

In December, the ministry said offer letters would be out by January. About 300 pharmacy graduates were then waiting for postings

Suddenly, job offers were frozen because of revisions to the New Public Service Remuneration Scheme. PSC said it did not have the power to release the offer letters because of orders from higher

Normally, intake for compulsory government service after the interview should take only one or two months.

The director-general of health told the press the problem had nothing to do with the allocations for placement or the new remuneration scheme and that this matter would be resolved by last Friday.

But just a couple of days later, PSC again said that our offer letters were frozen because of revisions to the remuneration scheme.

It is frustrating that although we were promised our offer letters by the end of this month and the problem solved by last Friday, we are still kept waiting without any clear explanation.

This is also despite the fact that fresh doctors received their offer letters this month after registering last month.

The revision of the new pay scheme is taking a long time and may cause our job placements to be delayed until the end of April. This means a total seven months' delay in getting our job offers.

Why can't we get our offer letters first and any adjustments to the salaries be done after the new scheme is implemented? **PHARMACY GRADUATES**

Delay in sending offer letters not intentional

HE Public Service Commission (PSC) would like to respond to the letter from C.D.R. on "Frustrating wait to serve the government" (NST, Feb 29) over the problem faced by pharmacy graduates who have yet to receive offer letters and job placements in the public service.

The PSC began to send offer letters from March 1 to 7,191 candidates who had been successful in the interviews by PSC for various positions.

Prior to this, we were unable to issue the offer letters due to the deferment of the Public Service Remuneration Scheme, because there were issues related to the changes in the terms and condi-

tions of service.

The Public Service Department, on Feb 27, issued a directive to insert additional conditions to the offer letters for all new appointments to further clarify the terms and conditions of service.

There has been no intentional delay on the part of the PSC on the issuance of the offer letters to successful candidates.

As the appointing authority, the PSC has to ensure that all appointments are implemented in accordance with policies and regulations currently in force.
